

**CAO CIGARS
“OUTPOST” SWEEPSTAKES
OFFICIAL RULES**

THE PROMOTIONS DESCRIBED HEREIN ARE INTENDED FOR PARTICIPATION IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA (“D.C.”) ONLY, EXCLUDING MASSACHUSETTS, MICHIGAN, AND VIRGINIA. 1. DESCRIPTION: The CAO Cigars “Outpost” Sweepstakes (each separate sweepstakes within, a “Promotion”; together, the “Promotions”), sponsored by Scandinavian Tobacco Group Lane Ltd. (the “Sponsor”) is offered online at caocigars.com/outpost during the separate entry periods described in Section 5 below (the “Entry Periods”). Sponsor’s computer is the official time-keeping device for the Promotions. Eligible entries received during a particular Entry Period will not be carried forward into any subsequent applicable drawing(s).

2. ELIGIBILITY: The Promotions are only open to individuals who: (a) are twenty-one (21) years of age or older at the date of entry; (b) are a legal resident of (and residing at the time of entry in) one of the 50 United States or D.C. (excluding Massachusetts, Michigan, and Virginia); and (c) were a smoker prior to learning of the applicable Promotion. On or about each of the Drawing Dates listed above, an independent judging organization will conduct a random drawing to select the potential winner(s) from among the applicable eligible entries as described above.
