

**CAPTAIN BLACK PIPE TOBACCO  
THE CLASSY GENTLEMAN PROMOTIONS 2023  
OFFICIAL RULES**

**THE PROMOTIONS DESCRIBED HEREIN ARE INTENDED FOR PARTICIPATION IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ("D.C.") ONLY, EXCLUDING MASSACHUSETTS, MICHIGAN, AND VIRGINIA. **1. DESCRIPTION:** The Captain Black Pipe Tobacco "The Classy Gentleman" Promotions 2023 (each, a "Promotion"; together, the "Promotions"), sponsored by Scandinavian Tobacco Group Lane Ltd. **2.
