2. ELIGIBILITY: The Promotions are only open to individuals who: (a) are twenty-one (21) years of age or older at the date of participation; (b) are a legal resident of (and residing at the time of participation in) one of the 50 United States or D.C. (excluding Massachusetts, Michigan, and Virginia); and (c) were a cigar smoker prior to learning of the applicable Promotion. The following individuals are NOT eligible to participate or win a prize: employees, officers and directors of Sponsor and its parent companies, subsidiaries, divisions, affiliates, advertising/promotion/judging agencies, and any other entities affiliated with the administration of the Promotions, and the immediate family members (parent, child, sibling, spouse) of each such person, and persons living in the same household as each such person (whether related or not). Participants further understand and agree that all rights under Section 1542 of the Civil Code of California ("Section 1542") and any similar law of any state or territory of the United States that may be applicable with respect to the foregoing release are hereby expressly and forever waived. - 10.
